Finance, Budget, and Policy Committee

Review of Financial Statements for Month ending 11/30/21: Mrs. Palmer made a brief presentation to the Board, noting that 41.92% of the fiscal year is complete. Property taxes received to date are \$2,316,306.21. To date we have used 40.34% of total expenditures. We have \$6,736,634.34 in unrestricted cash less current liabilities of \$192,086.21. Net cash available for operations is \$6,544,548.13. We have unrestricted cash to cover 22.3 months of operations.

Mr. Larkin made a motion to approve the statements as presented. Ms. Kao supported. Motion carried.

Updates from Board Committees

Building Reno Committee: The project continues to move forward at a quick pace. The terrazzo stairs are being installed this week. Supply chain issues have delayed us a bit, but things are coming along. OPN staffers will be here in a couple of weeks to examine and accept the furniture and review the punch list before we release Clark Construction.

Staff members from the Community Foundation of Greater Flint recently toured the building, led by former FDL Board member Moses Bingham. They really enjoyed seeing the Svea Kline tiles which were funded by the CFGF.
