## Finance, Budget, and Policy Committee

**Review of Pre-Audit Financials ending 6/30/20 (no action required):** Mrs. Palmer made a brief presentation to the Board, noting that 100.00% of the fiscal year is complete. Property taxes received to date are \$2,827,781.29 which is 100.20% of funds levied. To date we have used 100.48% of total expenditures. We have \$4,316,770.73 in unrestricted cash less current liabilities of \$515,421.21. Net cash available for operations is \$3,801,349.52. We have unrestricted cash to cover 12.9 months of operations.

## **Updates from Board Committees**

**Building Reno Committee:** Mrs. Schwartz and Mrs. Palmer met with Chad from Clark Construction yesterday, and the demo process continues to go well. Mrs. Schwartz showed pictures of the ongoing building demo to the group. We will need three months to move from the day we get the keys to the new building to ensure that all goes well with our reopening.

**Fundraising & PR Committee:** Total donations received to date for the FY21 campaign are over \$13k. Ms. Kale is chairing the 10/5/20 Virtual Learn for Life event and noted that five out of seven trustees have already confirmed that they will serve as virtual table hosts that day.

**Nominating Committee:** The committee has been busy and has some conversations scheduled with potential candidates on Monday, September 14. Trustees are encouraged to reach out to Mr. Larkin if you would like to serve as an officer for 2020-2021 as the officer election will be held at the October meeting.
