Mr. Larkin requested a motion to approve the agenda. Mr. Richardson made a motion to approve the agenda, Mr. Baines seconded. Mr. Larkin called the question, all present voting aye, no nays or abstentions. Motion passed.

A call was made to the public. No public attending via ZOOM wished to address the committee.

The committee reviewed the minutes from the September 24, 2020 meeting. Mr. Richardson made a motion to accept and file the August 27, 2020 minutes, Mr. Schlinker seconded. Mr. Larkin called the question, all present voting aye, no nays or abstentions.

New Business

Presentation of Annual Financial Report for the fiscal year ending June 30, 2020 by Plante Moran.

Mr. Larkin introduced Mrs. Pam Hill, CPA, Audit Partner with Plante Moran and Mrs. Ashley Frase, CPA, MBA Manager with Plante Moran to present the annual financial report.

Mrs. Hill stated that Plante Moran spent 175 hours of staff time working on this year's annual audit, including time spent on the new capital projects funds. The audit was conducted remotely, which led to additional work and the firm appreciates the help of FPL.

Mrs. Frase stated the library received an unmodified or clean opinion, which is the highest level of assurance the audit firm can provide that the financial statements are free from material misstatements.

Mrs. Frase reviewed the annual financial statements including the governmental funds balance sheet, the governmental funds statement of revenues, expenditures and changes in fund balance and the footnotes to the statements. The new long-term debt footnote as related to the bond issuance was pointed out to the committee. A schedule of the payments and interest to be paid on the bonds is included in the footnote. The legacy costs of the pension plans of the library were discussed.

Mrs. Hill reviewed the auditor's letter to the library board, noting there were no significant audit findings or disagreements. It was noted that management had disclosed a passed adjustment on the leasehold improvements made to the temporary space of \$233,434. Management had determined the useful life of the leasehold improvements were 18 months and did not require capitalization; thus, the amount of the leasehold improvements was expensed in FY 20. The effect on the financial statements was immaterial to the financial statements taken as a whole. Additional information of interest to the committee is included in the letter.

Discussion ensued. Mr. Larkin requested a motion to recommend approval of the audit to the Board of Trustees. Mr. Baines made the motion and Mr. Schlinker seconded. Mr. Larkin called the question, all present voting aye, no nays, or abstentions.

Old Business

Financial Statements and Investment Report – all funds for the fiscal year ending September 30, 2020

Mr. Larkin asked Mrs. Palmer to review the financial statements and investment report for all funds for the fiscal year ending September 30, 2020. The financial statements and investment report were displayed on screen. Mrs. Palmer reviewed the financial statements and the investment schedule for the general fund and the capital projects private fund and public fund with the committee. The statements as presented are preaudit at this time. Discussion ensued. Mr. Larkin requested a motion to recommend the statements to the Board of Trustees for approval. Mr. Richardson made the motion and Mr. Baines seconded. Mr. Larkin called the question, all present voting aye, no nays, or abstentions.
